1 Key Enhancements

The Aras Innovator 2023 Release Key Enhancements are outlined below:

1.1 Web Client Productivity

1.1.1 Grid Layouts Included with Favorite Searches

The ability for users to save and restore custom Grid Layouts (column visibility, width, order, etc.) has been improved by combining the capability with Favorite Searches. Now, when saving a Favorite Search, the user can optionally include the current Grid Layout along with the search criteria normally saved by a Favorite Search. Restoring a Favorite Search will update the view with the corresponding Grid Layout. Each Favorite Search will be returned with a unique view of columns and more, to quickly deliver relevant data to the user.

1.1.2 Claim Independent of Edit

Edit and Claim commands now function independently. Previously, setting an item to “Edit” mode also claimed the item. Now, setting an item to “Edit” mode does not claim the item. Previously, executing “Done” or “Discard” on a claimed item unclaimed it. Now, executing “Done” or “Discard” on a claimed item will not affect the claim status. The lock status of an item (locked_by_id) is now set when Edit or Claim or both are active. An item is only unlocked when it is neither claimed nor in edit mode.

This provides users with greater control over item lock status. If a user would like to keep an item locked between multiple edit cycles and/or multiple client sessions, they may now do so by claiming the item. “Done” and “Discard” commands, closing an item view tab, or ending a session will preserve the claim and therefore preserve the lock. Especially for automatically versionable items, this capability can be used to prevent the creation of excess automatic versions, preserving the business meaning of versions.

1.1.3 Improved Export to Excel

The Export to Excel function is significantly improved, for search grids, relationship grids, tree grid views, and item forms. The exported .xlsx file is opened directly in Excel with no warning message, and column alignment and formatted is preserved.

1.1.4 Copy Item Keyed Name and Hyperlink

Clicking the keyed name in the title bar of an Item View copies the keyed name text with embedded hyperlink to the clipboard.

1.1.5 Web Client and Controls

Styling and controls for many elements of the Aras web client have been updated for improved usability and consistency. This includes primary navigation, such as the login screen, the header and the navigation panel, item forms, the simple search data entry row, and grid rows.

With form styling, previously if you defined a custom style on a required field, the styling of required fields (blue) would override this. Now if you define a custom style on a required field, it overrides the required fields styling (which is now yellow).

1.1.6 Improved Tree Grid View Toolbars

The toolbar and context menu for Tree Grid Views have been updated to standard styling for consistency throughout Aras Innovator.

1.1.7 Sorting on Foreign Properties

Sorting on Foreign property fields is available through the UI by clicking on the column header, like sorting on other properties.

The sorting on Foreign properties is also available when running an AML query using the orderBy attribute.

1.2 Configurable Dashboards

A new low-code platform capability provides dashboards with interactive widgets for viewing and displaying data. Users can easily add widgets they want to see, choose the data displayed, and design the layout with drag & drop. Administrators can create reusable widget templates to help users get started.

1.3 Table of Contents (TOC) Editor

1.3.1 New TOC Editor

A new graphical editor has been introduced to enable administrators to configure the Table of Contents (TOC) in one place. New functionality includes the ability to define TOC buttons and categories, configure custom labels and icons for TOC buttons, and customize the sort order of TOC entries. Additionally, administrators can preview the TOC for specific identities within the TOC Editor. Refer to the Aras Innovator 2023 Release - Configurable User Interface Administrator Guide for step-by-step instructions for using the editor and configuring common use cases.

The TOC Editor creates Configurable User Interface (CUI) objects to define and render the TOC in the Aras Innovator web client. This approach replaces the old TOC Access and TOC View relationships on ItemTypes. The process to update existing packages requires three simple steps.

- Import the old package into the 2023 Release
- Use the TOC Editor to define any TOC buttons or categories required for the package
- Export the package using the package export utility.

Refer to the Aras Innovator 2023 Release - Configurable User Interface Administrator Guide for more details.

1.3.2 Configure Single Items as TOC Entries

The TOC Editor allows administrators to configure a single item as an entry in the TOC. One important use of this capability is to configure Dashboards as TOC entries.

1.3.3 TOC Editor Localized Content

Administrators can instantly preview multilingual content in the TOC Editor using the "View As" language filter. This means Administrators no longer need to log out of Aras Innovator or reconfigure their client machine settings to view the TOC in another language.

1.3.4 TOC Button Custom View Configuration

Administrators can use the TOC Editor to define buttons that display a custom Form view or custom HTML page within the Aras Innovator web client.

1.4 Technical Documentation Framework (TDF)

1.4.1 TDF Client API

A comprehensive Application Programming Interface (API) that provides functions to customize the Technical Document Editor using the Configurable User Interface (CUI) is now available.

1.4.2 TDF File Import API

The File Import API provides a framework for creating technical document content programmatically by extracting data from a selected file. Custom implementations extend this software API for specific File Types.

1.4.3 Dynamic Image Resizing

Image Document Elements within a Technical Document can be dynamically resized by selecting/dragging the image corners with the left mouse button. Resized images retain their original aspect ratio.

1.4.4 Drag and Drop Document Elements

Document Elements within a Technical Document can now be moved and/or copied to another location within the document by select/dragging within the Editor. The user interface provides a visual indication that identifies valid locations for moved/copied data to aid the author.

1.4.5 Create Graphics by Dragging/Dropping Image Files

Graphic Document Elements within a Technical Document can now be created by dragging/dropping one or more image files from the file system directly within an opened Technical Document.

1.4.6 Spell Checking for Technical Documents

The Technical Document Editor provides the ability to apply spell checking to text content. It leverages the spell-checking capability of the browser to scan and identify spelling errors in multiple languages.

1.5 Signing Certificates from Certificate Store

All Innovator servers and services can now read Signing Certificates from the file system and Certificate Store based on the OAuth configuration.

1.6 Mandatory Access Control (MAC) Identities

Mandatory Access Control (MAC) can now check user's membership to a provided list of Identities. If the user is a member of any of the identities in the list, the access is granted. This enhancement simplifies the creation of access rules to perform this check.

1.7 Federated Properties

The Federated data type for property definitions has been removed and replaced with a new Federated Boolean attribute. All existing Federated properties have been converted to Text properties with the new Federated attribute set to true.

Federated properties can now be created with specific data types by setting the federated flag when adding a property to an item type. The use of typed federated properties will support enforcement of type specific behavior and validations. The following types are supported as typed federated properties: Text, Integer, Float, String, Decimal, Boolean, and Date.

1.8 Configurator Services API Improvement

Retrieving valid combinations from large scope objects using the Configurator Services API is now more efficient.

1.9 .NET Framework to .NET Core Transition

In the Aras Innovator 2023 Release the Aras server components have been transitioned from .NET Framework to .NET Core. .NET Core has some significant advantages over .NET Framework, such as cross-platform support and better scalability.

1.10 Server Logging Updates

To make development, testing and troubleshooting easier, the following server logging enhancements have been implemented:

- Aras Innovator Server, Aras Innovator Web Client, OAuth server, Vault Server, Conversion Service and Agent Service have unified logs configuration in server's appsettings.json file. Default configuration is also unified and is the same for all servers and services after installation. Only fatal errors are logged by default.
- ASP.NET Core native logging mechanism (ILogger and ILoggerFactory) is available in CallContext public object. This mechanism uses server's log configuration and writes server methods logs along with other server's logs. Developers of server methods should use this mechanism for new development. Old public log API in CallContext is deprecated with appropriate messages and will be removed in the future.
